

**RESOLUTION REGARDING PUBLIC PARTICIPATION AT OPEN MEETINGS**

WHEREAS, Jim Wells County Emergency Services District No. 1 (“District”) is a political subdivision of the State of Texas, organized as provided by Article III, Section 48-e, of the Texas Constitution and Chapter 775 of the Texas Health and Safety Code (the “Code”), and operating pursuant to Chapter 775 of the Code; and

WHEREAS, the District has open meetings as required by Texas Government Code Chapter 551; and

WHEREAS, Section 551.007(b) of the Texas Government Code allows for members of the public to address the Board of Commissioners (“Board”) on an item on the agenda at an open meeting before or during the Board’s consideration of the item; and

WHEREAS, Section 551.007(c) of the Texas Government Code allows the Board to adopt reasonable rules regarding the public’s right to address the District;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF JIM WELLS COUNTY EMERGENCY SERVICES DISTRICT NO. 1 RESOLVE THAT:

Section 1.     The Board hereby adopts its rules regarding public participation at open meetings of the Board.

Section 2.     Individual members of the public may address the Board for a maximum of three minutes per person on items not on the current agenda (i.e., the public comment section of the meeting).

Section 3.     Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda (i.e., the public comment section of the meeting).


Section 4.     No formal action, discussion, deliberation, or comment will be made for items not on the current agenda.

Section 5.     Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.


Section 6.     The Board finds these rules to be reasonable.

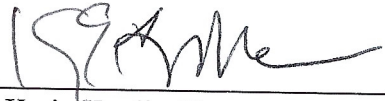

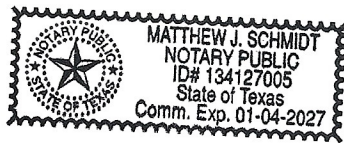
