Notice is hereby given that a regular monthly meeting of the Board of Commissioners of Jim Wells County Emergency Services District #1 was held on Tuesday November 12, 2024, at 7:00 p.m. at the Abel Perez Fire House (APFH) located at 101 FM 1540 in Sandia, Texas 78383 for the following purposes.

1. CALL TO ORDER AND DETERMINATION OF A QUORUM

Meeting was called to order by Board President Abraham Aguilar at 7:02 pm. Commissioners present were Karin Knolle, Matthew Schmidt, and Diana Hernandez. Commissioner Patrick Carter was not present. Business Administrator, Brien Nicolau, joined via phone. Firefighters present were Fire Chief David Bradfute, Captain Ron Cole, Liza Ochoa, and Gilbert Medrano.

4. SECRETARY'S REPORT

Commissioner Schmidt made a motion to accept the minutes of October 8, 2024, meeting as presented. Commissioner Hernandez seconded the motion. Motion passed unanimously.

5. TREASURER'S REPORT

Mr. Nicolau presented the Treasurer's Report. The beginning ESD #1 balance was \$30,960.23. The total for cleared checks and payments was \$11,527.74, total deposits were \$906.79, which included \$0.90 in interest. This brings the statement ending balance to \$20,339.28. The total for uncleared checks and new pending transactions was \$2,836.94, resulting in an ending register balance of \$17.502.34. Commissioner Hernandez made a motion to accept the report as presented. Commissioner Schmidt seconded the motion. Motion passed unanimously. Mr. Nicolau also stated that there was an oversite made to the old website when ESD #1 switched to a new website and there was a charge of \$1,058.75. There will be a refund to ESD #1 by NCS LLC because of the oversite made.

6. SVFD COMMAND STAFF REPORT

i. Fire Chiefs Incident, Operations, Vehicle, and APFH Maintenance Reports October 2024.

Fire Chief Bradfute presented there were 7 calls out of APFH and 0 calls for Sandia 534 Substation for October 2024. All Units are in service except for Unit 6 because of unsafe conditions. Unit 6 was relocated to 534 Substation and will be used for water storage only. Chief Bradfute will look into getting quotes to replace the front door at the station.

Chief Bradfute stated that the equipment and apparatus grants that were submitted this year were not approved. He will re-submit for approval for this upcoming year. Health and Wellness Grants are still under review and have not been approved at this point in time.
