Members of the public may collectively address the board for a total of 30 minutes on items not on the current agenda (i.e., the public comment section of the meeting).

In accordance with the Texas Open Meetings Act, no formal action, discussion, deliberation, or comment will be made for items not on the current agenda and any response to a public comment made on an item not published on the final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the board must be limited to a proposal to place the subject on a future agenda.

Individual members of the public may address the board for a maximum of three minutes per person per agenda item. Individuals may address the board once per item. Members of the public may collectively address the board for a total of 30 minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before the board discussion and consideration of the item.
